

REACH – Candidate List Substances of Very High Concern (SVHC)

Dear Customer,

According to REACH (Art.7), the products manufactured by Fedrigoni Self-Adhesives and supplied to our customers are defined as “articles”¹, and thus do not fall under the obligation to be registered according to REACH.

As a producer of articles, according to REACH our Company is a so-called “downstream user” of substances, and therefore does not fall under the obligation to register any substance according to REACH. An obligation to register only exists for downstream users in case of direct import of substances or preparations from outside the European Union: for our Company, this is not the case.

The duties of registration are binding for our suppliers, or for their suppliers: our suppliers assured us that substances contained in the products we use are already registered at the European Chemical Agency (ECHA).

According to Article 33 of the REACH Regulation, there is an obligation to inform customers regarding the presence of any substance in the current SVHC candidate list which exceeds the concentration of 0,1 % w/w in our products.

Fedrigoni Self-Adhesives confirms that none of these “Candidate List Substances” is intentionally added in the manufacturing of our products; in addition, on the basis of the information provided by our suppliers, we are confident that none of our products contains Candidate List Substances, as for the **SVHC list updated 23/01/2024**, in a concentration exceeding the 0.1 % w/w.

Exceptions to this statement are represented by the products listed in TABLE 1, which contain > 0.1 % w/w of the following substance included in the Candidate List of Substances of Very High Concern (SVHC) dated January 17, 2023, pursuant to Article 59 (1.10) of the REACH Regulation:
